## “Fixing a Hole”

The 2014/15 Street Improvement project will include major repairs to Slocum Street from Mears to Iowa; Lincoln Street from Warner to Mary; and Mary Street. These streets were chosen based on a “rating” using engineering standards combined with a pressing need for underground sewer and

water upgrades. The project is estimated to cost 1.6 million. All but \$243,000 can be funded with anticipated revenues and fund reserves. To cover the gap, the City added three mills to the tax bills which you recently received. This will cost the average home owner an extra \$120. The City Council will

review the need for a street millage on an annual basis.

## “We Can Work It Out”

The City Council just passed a \$6.8 million operating budget for the fiscal year which began July 1. Rather than bore you with how revenues have been declining, reduced, and withheld, let’s talk about proactive choices the City has made to meet our financial challenges. The Industrial Park has paid off its debt. Bonds for streets, the downtown, the water system, and the sewer system will expire in the next two years. This will reduce annual debt payments

by \$356,000.

The cost to treat sewage waste will increase 5%. To zero out the effect of this to our customers, we have reduced our water rates 10%. The water fund is in a much healthier financial position than the sewer fund and can absorb this lost revenue without any significant reduction in services.

The City has made significant changes to the benefits offered to our employees including

higher co-pays and reduced post-employment costs. We have reduced pay scales for new employees and have restructured our staffing. These changes are expected to save \$544,000 in payroll costs over the next five years.

## “Don’t Let Me Down”



It seems that each season, no matter how much we like it, brings with it some tedious tasks. For summer it's mowing the lawn. Some people like their yard work and it shows; others, not so much, and that shows too. But mowing the grass isn't just about looks. An unmowed lawn creates pollens that can

aggravate allergies and provides a home for unwelcome guests like fleas, ticks, mosquitos, mice and snakes. That impacts the health of other people.

Because of the concern for public health the City of Whitehall has an ordinance that requires residents to mow their lawns and the police

department is active in enforcement. The first step is always to notify residents to mow their lawn but citations will be issued for uncorrected violations. Improve the looks of your home, be a good neighbor and save yourself some money. Keep your lawn well mowed.

## “Help”

### ATTENTION WATER CUSTOMERS WITH SECONDARY WATER METERS

To protect you and the city water supply the State of Michigan (DEQ) requires that all of these services have a backflow protection device, that the testable devices be tested, and a copy of that test be given to the City of Whitehall Department of Public Works for reporting to the state.

The deadline for submitting the backflow test results to the City is November 15, 2014. We are suggesting that before you shut your system down for the winter, you have your

device tested and submit the test results. If we do not receive a copy of your test results by November 15, 2014, your secondary meter will be removed.

PVB and RPZ devices are testable and must be tested every three years. Testing must be done by a licensed Master Plumber that is a certified tester. We maintain a list of certified testers in this area.

We have an extensive Cross Connection Program in place which is regulated by the State of

Michigan Department of Environmental Quality Water Bureau to protect our public water supply system.

Lighting has recently been

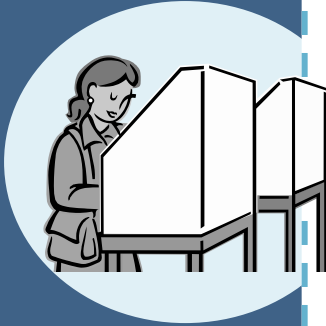

## Election Information

All registered voters for the City of Whitehall vote at City Hall, 405 E. Colby Street. Polls open at 7 a.m. and close at 8 p.m. To find out if and where you are registered to vote, check out [www.michigan.gov/vote](http://www.michigan.gov/vote).

### Primary Election: August 5, 2014

**Voter Registration** - The last day to register to vote for the August 5 Primary Election was July 7, 2014.

### General Election: November 4, 2014

**Voter Registration** - The last day to register to vote for the November 4 General Election is October 6, 2014

If you have not already registered to vote, you may do so at any Secretary of State's office, or at Whitehall City Hall at 405 E. Colby Street.

Absentee ballots are available for persons: who are college students or anyone planning on being out of town on Election Day; physically unable to attend the polls without assistance; 60 years or

over; appointed as election inspectors in a precinct other than where they vote; confined to jail awaiting arraignment or trial; with religious tenets that prohibit one from attending the polls. Ballots can be mailed to the voters registered address, college address, or another location if specified on the application up until 2 p.m. the Saturday before the election. The City Clerk will be in the office on Saturday, August 2 (for Primary election) and November 1 (for General election) to issue and receive absentee ballots. Absentee ballots must be returned to the City Clerk by 8:00 p.m. on Election Day.

And remember, as always, picture identification is required for someone to vote without signing an affidavit. Voters can satisfy the picture identification requirement by showing a Michigan driver's license or a Michigan personal identification card. Other forms of identification may be used, check with your local clerk for a list of accepted documents.
