“What’s Happening?!”

The first of July always rings in a new budget year for the City. The Council has authorized expenses of \$7.6 Million against anticipated revenues of \$6.2 Million. Nine of the fourteen funds will draw down on cash reserves to balance the budget. The hardest hit fund will be our downtown with a potential loss of nearly \$800,000

and jeopardizing planned renovations to the downtown next summer. This is entirely due to the elimination of personal property taxes and the uncertainty of promised reimbursement from the State.

Misco Street between Mears and Lake will be reconstructed later this summer thanks to

anticipated state and federal grants of \$317,000. Sewer rates will be increased by \$0.13 per thousand gallons beginning January 1 while water rates will remain as is. Major utility projects include a new sewer lift station to service the Tannery development and painting the water tower on Peach Street.

Water Shutoff Policy

We had a record number of water shutoffs as a result of delinquent accounts this past quarter. If you are having trouble making your payment, please call us to arrange a payment agreement.

As of July 1, 2015, the City adopted a new Water Shut Off Policy.

We will no longer be collecting deposits on delinquent accounts in order to have the water turned back on. The policy is as follows:

If water service is shut off, the resident must pay their outstanding bill in full and is responsible for the following fees and fines:

Turn on fee \$50.00 (regular hours) **AND an additional \$50.00** (if after 3:30 p.m.)

IF water service shut-off

should occur again, in addition to the Turn On Fee, the following will also apply:

Non-refundable fines

\$50.00 (2nd offense),
 \$100.00 (3rd offense),
 \$200.00 (4th offense)

\$200.00 will also be assessed for all subsequent offenses after four.

Summer property taxes are due by July 31. Payment must be received on or before July 31 otherwise penalties will be applied—postmarks are not accepted.

Applications for summer 2016 tax deferments are being currently accepted for the eligible taxpayers who are 62 years of age or older, paraplegic, quadriplegic, service person, veteran, widow or widower or blind.

To qualify, taxpayers must certify that their gross household income for the preceding calendar year did not exceed \$40,000. Forms are available at City Hall, 405 E. Colby Street in Whitehall.



Election Information

All registered voters for the City of Whitehall vote at City Hall, 405 E. Colby Street. Polls open at 7 a.m. and close at 8 p.m. To find out if and where you are registered to vote, check out www.michigan.gov/vote.

Primary Election: August 2, 2016

Voter Registration - The last day to register to vote for the August 2 Primary Election was July 5, 2016.

General Election: November 8, 2016

Voter Registration - The last day to register to vote for the November 8 General Election is October 4, 2016

If you have not already registered to vote, you may do so at any Secretary of State’s office, or at Whitehall City Hall at 405 E. Colby Street.

Absentee ballots are available for persons: who are college students or anyone planning on being out of town on Election Day; physically unable to attend the polls without assistance; 60 years or over; appointed as election inspectors in a precinct other than where they vote; confined to jail awaiting arraignment or trial; with religious tenets that prohibit one from attending the polls. Ballots can be mailed to the voters registered address, college address, or another location if specified on the application up until 2 p.m. the Saturday before the election. The City Clerk will be in the office on Saturday, August 2 (for Primary election) and November 1 (for General election) to issue and receive absentee ballots. Absentee ballots must be returned to the City Clerk by 8:00 p.m. on Election Day.
