“A Little Street Where Old Friends Meet” **Colby Street—Reconstruction & Widening**

What Is Being Done?

The Michigan Department of Transportation (MDOT) will be completing a mix of resurfacing and reconstruction with widening on US-31 Business Route (Colby Street) from the White River bridge to east of Hall Street.

In addition to the roadwork, water mains will be relocated and upgraded, and sidewalk ramps will be upgraded to be compliant with the Americans with Disabilities Act. The City of Whitehall will also be completing a street-scaping project along US-31 BR in coordination with the MDOT project.

When Will This Be Done?

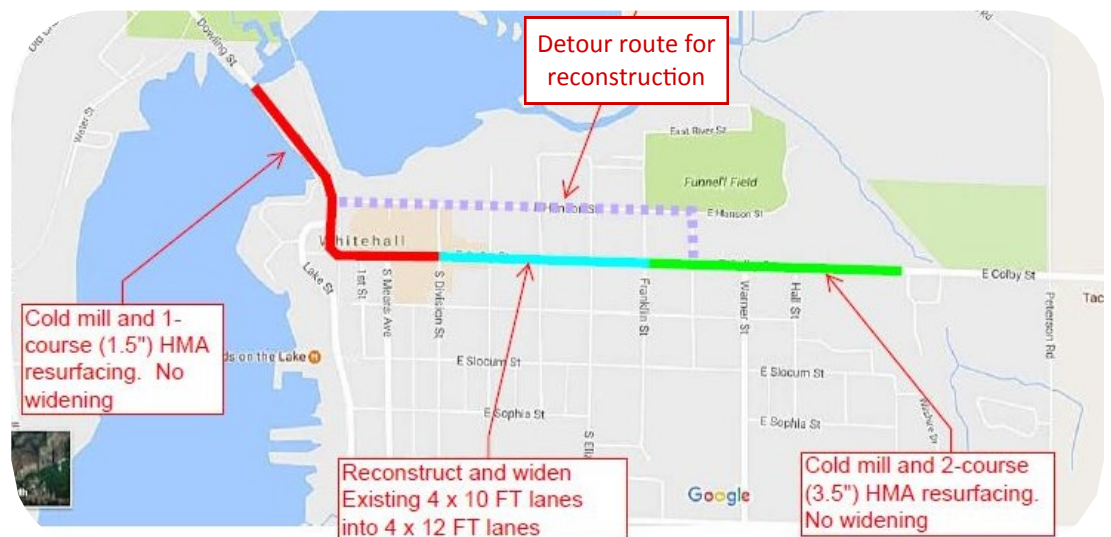
Work will begin on April 3rd and is scheduled to be completed by June 19th.

How Will Traffic Be Affected?

Lane closures will be in effect throughout the project. During reconstruction, traffic will be detoured on Hanson and Covell streets. Residential and business access will be maintained within the detour limits. Pedestrian traffic will be detoured where sidewalk closures are necessary.

Call for Help

The City of Whitehall has police officers on duty 24/7/365 and they are all eager to help you whenever you need. Muskegon Central Dispatch is also there 24/7/365 to get your call to the officers. While you should call 911 in an emergency, for non-emergency calls you can call 231-722-3524. There are a few simple prompts but then you will be talking to the same people that answer 911 calls and the same people that send all public safety services to their calls. Calling the non-emergency number ensures the correct services and agencies are sent to you.

Whitehall PD also has their own business number that is answered during business hours. Call us at 231-894-2317 Monday – Friday, 8 am to 5 pm but if we don't answer, don't wait, call 231-722-3524 for assistance.

Speaking of 911, have you signed up for Smart911? You can provide emergency information on a secure database that can only be accessed by Central Dispatch during an emergency. Medical conditions, hidden key locations, emergency contacts and even your pet information can be included. Go to www.smart911.com and register today.

“Rules of the Road”

Snow Removal

As a reminder that when removing snow from private property it is unlawful to deposit, or cause to be deposited, snow, ice, or slush on any roadway or highway. Traffic Codes may be viewed in their entirety at City Hall.

The Fire Authority asks that property owners keep fire hydrants clear of snow to assist them in accessing the hydrants during an emergency.

Please make sure that your mailbox and post are in sound order. **IF** the City's plow truck physically hits the box or post the City will make repairs or replace it. However, **IF** the snow load damages the box or post it will be the responsibility of the property owner to repair or replace it.



Sidewalk Snow Removal:

City sidewalk snow removal will be back this year. The priority will be routes leading to and from the schools and also downtown. Other sidewalks will be cleared subject to available funding and manpower. It is still, by local ordinance the adjacent property owner's responsibility to clear their sidewalk in a timely manner.

“Take a Fool’s Advice”

2017 Small Business Exemption for Commercial Personal Property

About the exemption

Last year, businesses with less than \$40,000 Taxable Value of personal property owned, leased or used by them (or any related entity) within a tax collecting municipality could qualify for an exemption if they timely file the Michigan State Tax Commission affidavit. This exemption continues in 2017. Exemption affidavits must be fully completed and in the assessor’s hands by the deadline.

How to file

If your commercial personal property is less than

\$40,000 Taxable Value, please fill out **Treasury Form 5076 “Affidavit of Owner of Eligible Personal Property Claiming Exemption from Collection of Taxes.”**

Where and When to file

To be considered for exemption, the required affidavit must be received by **Feb. 10, 2017.**
